**FIRST AMENDMENT TO THE DECLARATION
OF COVENANTS, CONDITIONS AND RESTRICTIONS
FOR CASTLEBROOK AT RIDGEVIEW**

INTRODUCTORY PROVISIONS

WHEREAS, the Declaration of Covenants, Conditions and Restrictions for Castlebrook at Ridgeview was executed by Pasquinelli Portrait Homes, L.P., a Texas limited partnership, as Declarant, filed on November 8, 2001, in Volume 05042, Page 03231, *et seq.* of the Land Records of Collin County, Texas (the "*Castlebrook Declaration*"); and

WHEREAS, the Castlebrook Declaration affects certain tracts or parcels of real property in the City of Plano, Collin County, Texas, more particularly described on Exhibit "B" attached hereto (the "*Addition*"); and

WHEREAS, pursuant to Article XIII, Section 13.3 of the Castlebrook Declaration, the terms and conditions contained in the Castlebrook Declaration may be amended by the Owners representing not less than ninety percent (90%) of the Lots within the first twenty (20) year period from the date the Castlebrook Declaration is recorded; and

WHEREAS, Owners representing not less than ninety percent (90%) of the Lots of the Castlebrook at Ridgeview Homeowners Association have voted in favor of the following amendment to the Castlebrook Declaration as evidenced by Exhibit "A" attached hereto.

NOW, THEREFORE, the Castlebrook Declaration is hereby amended as follows:

Article V, Section 5.11 of the Castlebrook Declaration is hereby deleted and shall hereinafter read in its entirety as follows:

Section 5.11 Initial Working Fund. At the time of closing of the first sale and all subsequent sales of each Lot, a sum equal to at least two months' assessments for such Lot (the "Capitalization Fee"), at the rate current at the time of closing, shall be collected from the purchaser of such Lot and transferred to the Association to be held as an initial working capital fund. The purpose of said fund is to ensure that the Association will have adequate cash available to meet expenses contemplated herein, as well as unforeseen expenses, and to acquire additional equipment or services deemed necessary or desirable. Amounts so paid into the working capital fund shall not be considered an advance payment of regular assessments.

The terms and provisions of the Castlebrook Declaration, except as modified herein, are hereby declared to be in full force and effect with respect to the Addition. The Addition shall continue to be held, occupied, sold and conveyed subject to the terms and conditions of the Castlebrook Declaration and this First Amendment, which shall run with title to the Addition and are binding on all parties having any right, title or interest in and to the Addition or any part thereof, including their heirs, representatives, successors, transferees and assigns, and shall inure to the benefit of each Owner thereof.

IN WITNESS WHEREOF, the members of the Castlebrook at Ridgeview Homeowners Association have caused this First Amendment to the Castlebrook Declaration to be filed with the office of the Collin County Clerk and is made to be effective as of the 24th day of July, 2007.
