periods of ten (10) years unless by a vote of the majority of the then owners of the land it is agreed to change said covenants in whole or in part; provided however, that any covenant, condition, easement or lien may be changed or deleted in whole or in part at any time by a majority vote of the owners of the land.

All properties shall have impressed thereon the following restrictions:

SECTION A. CONSTRUCTION CONTROL

1. Before ANY preparation or foundation is begun for new, permanent construction or additions to existing structures, tract owner must furnish plans, specifications and the name of the general contractor or a list of each contractor involved to the Board of Directors.
2. Prior to initiation of construction, the Board of Directors must approve, in writing, the plans, specifications and site plan for structures or improvements to be constructed on the tracts.
3. The Board of Directors may refuse to approve plans and specifications which do not comply with the Association Agreement, Covenants, and/or Bylaws of the Association.
4. In the event the Board of Directors fails or refuses to approve, modify or disapprove in writing any request for approval of plans and specifications within thirty (30) days after said written request is made, approval will be deemed to be granted.
5. If the tract owner fails to comply with this section, a lien will be initiated against said tract in the amount of Two hundred and fifty dollars (\$250.00).

SECTION B. LAND USE

1. No tract shall be used except for residential purposes for the enjoyment of country living. The use of the tract for a home-based business shall not be evident or visible from the exterior of the home.
2. No tract may be subdivided into smaller tracts.
3. Building location: No building shall be erected on any tract closer than seventy-five (75) feet to the center line of the roadway. No building shall be located nearer than ten (10) feet to an interior tract line.

SECTION C. BUILDING TYPE

1. No building shall be erected, altered, placed or permitted to remain on any tract other than:
 - a. One (1) detached single-family dwelling not to exceed two (2) stories in height, excluding a basement.
 - b. Private garage and sheds
 - c. Barns and outbuildings for the purpose of caring for livestock for personal use.
2. No shed, barn or other out building shall be constructed between the dwelling unit and the main road.
3. All structures are to be new construction approved by the Board of Directors.
4. No mobile homes allowed.
5. Dwelling size: No dwelling building shall be erected on any site or tract which contains less than fourteen hundred (1400) square feet in total dwelling area. No area of the garage or carport shall be included in dwelling area.
6. No outside toilet facilities shall be used, constructed or maintained on any tract. All plumbing and drains must be connected with water tight septic tanks.
7. No structure of a temporary character shall be erected for use at any time. This is not to be construed to mean a portable storage building.
8. The exterior of all structures must be completed within nine (9) months from approval of the project.
9. No construction project shall remain dormant for more than two (2) weeks without prior approval of the Board of Directors and in no event shall this section preclude enforcement of Section 8 immediately above.
10. If a tract owner fails to comply with this section, a lien will be initiated against said tract in the amount of two hundred and fifty dollars (\$250.00) plus filing fees for the first month of noncompliance and five hundred dollars (\$500.00) plus filing fees per month thereafter until date of compliance.

SECTION D. FENCES

1. All front fences between the front property line and the seventy-five (75) foot building set back line shall be of wood, chain-link type (cyclone) or other type approved by a majority of the Board of Directors pursuant to a written request by the tract owner. The other fences shall be left to the discretion of the owner(s).

SECTION E. LIVESTOCK

1. When livestock is kept, such livestock must be fenced in on all tracts.
2. Only one (1) large livestock animal will be permitted per acre or fractional part thereof.
3. Under no circumstances will swine be kept or raised on any tract.

SECTION F. MOTOR VEHICLES

1. No vehicle shall be permitted to remain on the premises without current license plates and inspection sticker for a period of time in excess of thirty (30) days. Farm or garden type machines are NOT in this category of motor vehicles.
2. No trail bike, motorcycle, dune buggy, go-cart, four-wheeler, tractor or other wheeled vehicle shall be driven so as to constitute a nuisance by virtue of speed, noise, visible exhaust, emissions or otherwise.
3. The maximum speed limit within the area is twenty-five (25) M.P.H.

SECTION G. GARBAGE AND REFUSE DISPOSAL

1. UNCONTAINED trash, garbage or other waste shall never be placed at the roadside earlier than the morning of a designated pickup time of collectors.
2. Containers, bags and other CONTAINED refuse shall never be placed at the roadside earlier than twenty-four (24) hours before a designated pick up time of collectors.
3. At no time shall loose garbage be "dumped" on a tract unless part of a verifiable compost heap.
4. All non-operational farm/garden equipment, motor vehicles, motorcycles, go-carts, four-wheelers and the like shall be concealed to avoid unsightliness.
5. All construction material remaining thirty (30) days after completion of construction shall be properly disposed of or concealed to avoid unsightliness.
6. No tract shall be used or maintained as a junkyard or as a dump ground for rubbish. The determination as to whether a "junkyard" or "dump ground" exists shall be made by a majority vote of a panel of three tract owners with one selected by each of: the affected tract owner, the complaining tract owner(s) and the Board of Directors. No tract owner may appoint him/herself to serve on the three person panel.
7. If an owner, after one ten-day notice, fails to maintain his/her tract within these specifications, the Board of Directors may employ someone to remove the offensive materials and thereafter bill the tract owner. If the owner refuses to reimburse the association, a lien will be initiated against said tract in an amount equal to the cost of removal plus filing fees for a violation of this section.

SECTION H. CONSTRUCTION EXEMPTION

1. During active construction, any of the previous sections may be waived by a majority vote of the Board of Directors.

IN WITNESS WHEREOF, the President of the Association hereby executes this Amendment evidencing that Ballots attached hereto as Exhibit "B" and incorporated herein represent the approval of these modifications to the Declaration to be effective as of March 1, 1998 and upon filing of record in the official public records for real property in Collin County, Texas.

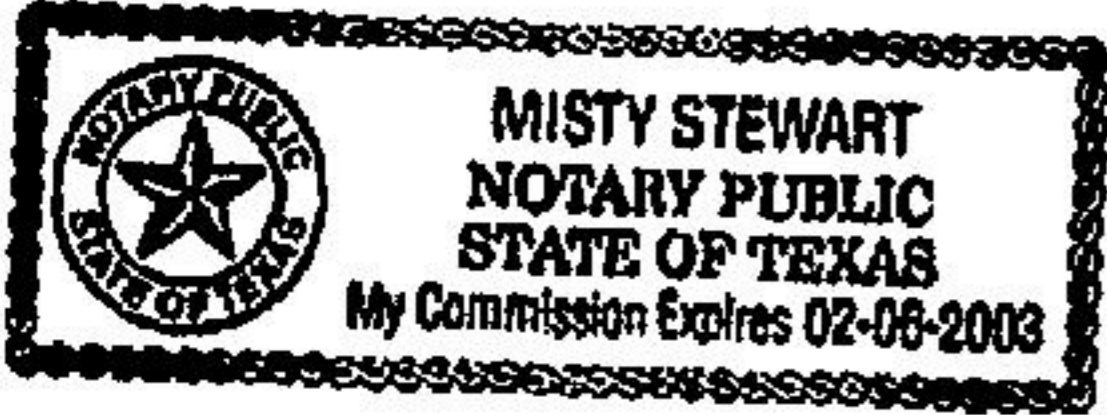

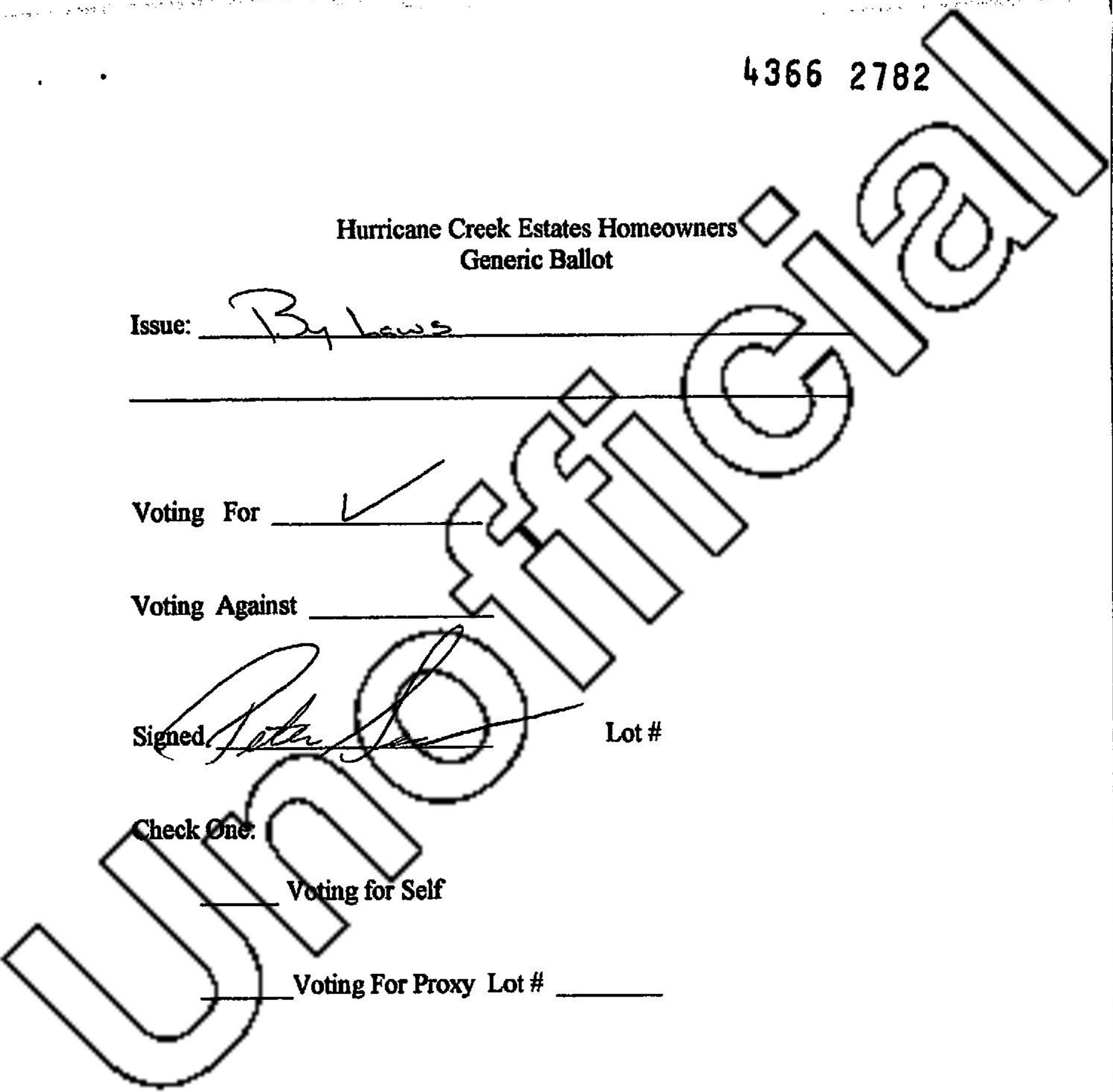


