SUPPLEMENTAL DECLARATION OF  
COVENANTS, CONDITIONS AND

Whereas, Declarant has subjected Sections 1, 2, 3, 4, 5, 6, 7 and 8, Marsh Oaks "A Performance Development", as the same are shown on maps thereof recorded in Map Book 39, Page 21, Map Book 39, Page 115, Map Book 39, Page 362, Map Book 40, Page 58, Map Book 41, Page 27, Map Book 41, Page 29, Map Book 41, Page 145, and Map Book 41, Page 145, of the New Hanover County Registry, to a Declaration of Covenants, Conditions and Restrictions for Marymount at Marsh Oaks "A Performance Development" (the "Declaration") recorded in Book 2584 at Page 0933, New Hanover County Registry, as amended; and

Whereas, the Declarant has added Section 9 to Marsh Oaks "A Performance Development", Section 8 being shown on a map thereof recorded in Map Book 41, Page 163, in the office of the Register of Deeds of New Hanover County; and

Whereas, the Declarant desires for Section 9 of Marsh Oaks "A Performance Development" to be subject to the Declaration.

Now, therefore, Declarant hereby declares that all of the property within Section 9 of Marsh Oaks "A Performance Development", as described above, shall be held, sold and conveyed subject to the Declaration, which Declaration shall run with the land and be binding on all parties having any right, title or interest in the described property or any part thereof, their heirs, successors or assigns, and shall inure to the benefit of each owner thereof.

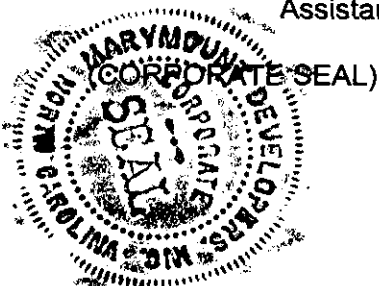
