SECOND AMENDMENT OF CONSOLIDATED DECLARATION OF COVENANTS AND
RESTRICTIONS, PHASES I & II, MONTICELLO ADDITION, CITY OF SOUTHLAKE, TEXAS
and
PHASES I, II, III, & IV, MONTICELLO ADDITION,
COLLEYVILLE, TEXAS

WHEREAS, the Monticello Addition to the City of Southlake, Tarrant County, Texas, was created in two (2) phases and each phase had their own set of Covenants and Restrictions and which are recorded in the Deed Records, Tarrant County, Texas, as follows:

1. Phase I recorded in Volume 10429, Page 0164, in reference to the lots reflected on the Plat recorded in Cabinet A, Slide 862, Plat Records, Tarrant County, Texas; and
2. Phase II recorded in Volume 11011, page 2195, in reference to the lots set forth on the Plat recorded in Cabinet A, Slide 1280, Plat Records, Tarrant County, Texas, and more particularly described as Lots 1 through 4, Block 3; Lots 11 through 25, Block 4; and Lots 29 through 32, Block 2, Monticello Addition, an Addition to the City of Southlake, Tarrant County, Texas;

WHEREAS, the Monticello Addition to the City of Colleyville, Tarrant County, Texas, was created in four (4) phases and each phase had their own set of Covenants and Restrictions and which are recorded in the Deed Records, Tarrant County, Texas, as follows:

1. Phase I recorded in Volume 09150, Page 2090, in reference to the lots set forth on the Plat recorded in Volume 388-209, Page 12, Plat Records, Tarrant County, Texas;
2. Phase II recorded in Volume 09677, Page 887, in reference to the lots reflected by the Plat recorded in Cabinet A, Slide 95, Plat Records, Tarrant County, Texas;
3. Phase III recorded in Volume 10040, Page 2055, in reference to the property reflected by the Plat recorded in Cabinet A, Slide 401, Plat Records, Tarrant County, Texas, and more particularly described as lots 1 through 19, Block 8, and Lots 1 through 10, Block 9, MONTICELLO ADDITION, PHASE III, an Addition to the City of Colleyville, Tarrant County, Texas; and
4. Phase IV recorded in Volume 09876, Page 1439, in reference to the property reflected by the Plat recorded in Cabinet A, Slide 340, Plat Records, Tarrant County, Texas, and more particularly described as Lots 23 through 30, Block 2, MONTICELLO ADDITION, PHASE IV, an Addition to the City of Colleyville, Tarrant County, Texas;

WHEREAS, on December 4, 1995 there was filed a Consolidated Declaration of Covenants and Restriction in reference to the property described above and which Consolidation is filed in Volume 12186, Page 0005, Deed Records, Tarrant County, Texas;

WHEREAS, pursuant to paragraph XIV(B), of the Consolidated Declaration of Covenants and Restrictions allows for the revocation and amendment thereof;

WHEREAS, property owners holding at least sixty-six and two-thirds (66 2/3%) percent of the total vote in the phases of the Monticello Addition described above have approved in writing the amendment set forth herein as required by the Consolidated Declaration of Covenants and Restrictions;

WHEREAS, the Association, pursuant to Article XIV(B), has confirmed in writing that to its knowledge no notice of interest has been given to the Association by any holders of any recorded deed of trust;

NOW THEREFORE, KNOW ALL MEN that the undersigned wish to revoke and delete the following portion of Article VII, Section D, to-wit;

D. Mineral Operations: No drilling, oil development operations, oil refining, quarrying, or mining operations of any kind shall be permitted upon or in the Properties, nor shall oil wells, storage tanks, tunnels, mineral excavations or shafts be permitted upon or in the Properties. No derrick or other structures designed for use in boring for oil or natural gas shall be erected, maintained, or permitted upon the Properties.

and to substitute in its place the following:

D. Mineral Operations: No mineral, gas or oil drilling, development, refining, quarrying, or mining operations of any kind, or operations incidental to the foregoing, shall be permitted upon the surface of the Properties, nor shall oil wells or storage tanks be permitted upon the Properties. No derrick or other structures designed for use in boring for oil or natural gas shall be erected, maintained, or permitted upon the surface of the Properties. Nothing in this provision shall prohibit the subsurface development of oil and natural gas under and within the Properties. "Mineral" as used in this paragraph shall mean those minerals set forth in Section 75.001(a)(1) of the Texas Property Code.

NOW THEREFORE, KNOW ALL MEN that for and in consideration of amending the mineral operations restriction in Article VII, Section D, and the establishment of uniform mineral operations standards, the adequacy of which is hereby acknowledged, that the owners of the property in Phases I and II, Monticello Addition to the City of Southlake, Tarrant County, Texas, and the owners of the property in Phases I, II, III and IV, Monticello Addition to the City of Colleyville, Tarrant County, Texas, to wit, that the following Article VII, Section D of the Consolidated Declaration of Covenants and Restrictions heretofore filed in Volume 1286, page 0005, Deed Records, Tarrant County, Texas be and is hereby revoked and deleted:

D. Mineral Operations: No drilling, oil development operations, oil refining, quarrying, or mining operations of any kind shall be permitted upon or in the Properties, nor shall oil wells, storage tanks, tunnels, mineral excavations or shafts be permitted upon or in the Properties. No derrick or other structures designed for use in boring for oil or natural gas shall be erected, maintained, or permitted upon the Properties.

and the following is substituted in its place:

D. Mineral Operations: No mineral, gas or oil drilling, development, refining, quarrying, or mining operations of any kind, or operations incidental to the foregoing, shall be permitted upon the surface of the Properties, nor shall oil wells or storage tanks be permitted upon the Properties. No derrick or other structures designed for use in boring for oil or natural gas shall be erected, maintained, or permitted upon the surface of the Properties. Nothing in this provision shall prohibit the subsurface development of oil and natural gas under and within the Properties. "Mineral" as used in this paragraph shall mean those minerals set forth in Section 75.001(a)(1) of the Texas Property Code.

Except as set forth above, the Consolidated Declaration of Covenants and Restrictions referred to above be and are hereby ratified.
