

**SECOND AMENDMENT  
RESTRICTIONS AND COVENANTS  
SADDLE CLUB SOUTH  
MIDLAND, TEXAS**

The undersigned, being two-thirds (2/3) of the owners of the lots subject to the Restrictions and Covenants dated March 29, 1977 recorded in Volume 503, Page 464 Deed Records, Midland County, Texas as amended by Supplemental Restrictions and Covenants to the Existing Covenants for Saddle Club South to Establish the Saddle Club South Homeowners Association dated December 8, 1980 recorded in Volume ~~646~~ Page ~~361~~ Deed Records, Midland County, Texas (collectively, the "Covenants and Restrictions") hereby adopt this Second Amendment to Restrictions and Covenants for Saddle Club South (this "Amendment").

1. Article I, Item 10 of the Covenants and Restrictions shall be amended to read in its entirety as follows:

10. At least sixty percent of the exterior wall surface of each residence (excluding doors, windows and exterior glass) shall be of brick, rock, stone, brick veneer, rock veneer, stone veneer or stucco. The roof of all residences shall be covered with one of the following:

- a. wooden or shake shingles,
- b. the dimensional laminated architectural type shingles which are at least 300 pounds per square and carry at least a 30 year warranty and which are weathered wood in color; or
- c. such other material as may be approved in any single instance by the Board of Directors of the Saddle Club South Homeowners Association.

2. Nothing contained in this Amendment shall be construed so as to require membership in the Saddle Club South Homeowners Association of any lot owner which is not presently a member of the Saddle Club South Homeowners Association.

3. Except as amended hereby, the Covenants and Restrictions are hereby ratified and affirmed.

4. This Amendment may be executed in any number of counterparts but shall be considered as one original.
